After detailed deliberation amongst the members of the Approval Committee as well as interaction with Developer/ Representatives of the Units/ Applicants, the following decisions were unanimously taken:

The approval Committee also directed the customs division of JSEZ to carry out verification of stock and plant & machinery of the unit.
