

Minutes of the Approval Committee Meeting of Jaipur Special Economic Zone, Sitapura (Multi Product SEZ) held at 11:00 AM on 20.11.2023 under the chairmanship of Shri A. Bipin Menon, Development Commissioner through Video Conferencing.

It was informed that the quorum was complete and the meeting could proceed.

The Chairman welcomed the participants at the outset and then the agenda taken up sequentially. After detailed deliberation amongst the members of the Approval Committee as well as interaction with Developer/ Representatives of the Units/ Applicants, the following decisions were unanimously taken:

Agenda Ratification of Minutes of Approval Committee meeting No. 1 held on 20.09.2023:

It was informed that no reference had been received against the decisions of the Approval Committee Meeting held on **20.09.2023** from any of the members of the Approval Committee/ Trade/ Unit. Therefore, the Minutes of the meetings of Approval Committee held on 20.09.2023 were unanimously ratified.

2.4. It was also clarified that inter unit transfer of these three products would be allowed only between gems and jewellery units within the same SEZ, i.e., within SEZ-II, Sitapura, Jaipur.

Agenda No. 3 **Proposal of revocation of suspension of LOA after mis-declaration of Imported Goods by M/s Emerald Distributors:**

3.1. The proposal of M/s Emerald Distributors, H1-137, Phase-II, Sitapura Industrial Area, Jaipur on mis-declaration of imported goods was discussed in the meeting.

3.2. Shri Sunil Mehta, Partner appeared before the Approval Committee on behalf of the unit and requested for revocation of suspension of LOA. On being asked by the committee, he informed that unit will take care of new suppliers in future.

3.3. The approval committee unanimously revoked the suspension of LOA till **31.12.2024** subject to 100% examination of all imports/exports of the unit by JSEZ Customs and deposition of RIICO dues amounting to Rs. 38,400/-.

The unit has not applied for renewal of LoA even after several reminders from JSEZ office. After due deliberations, the committee unanimously decided to treat the LOA of M/s Gitanjali Gems Limited as cancelled as already lapsed with effect from expiry of its validity, i.e., 20.12.2020. This was keeping in view that no exports were undertaken since 2018-19. Further, the Approval Committee directed RIICO (Developer) to start appropriate action against the unit, as deemed fit.

Agenda No. 5 **Proposal of Monitoring of the case of M/s Firestar International Pvt. Ltd.:**

5.1. The proposal of M/s Firestar International Pvt. Ltd., Plot No. G1-181, Phase-II, Sitapura Industrial Area, Jaipur was discussed in the meeting.

5.2. **No one appeared before the Approval Committee.**

5.3. The approval committee took a serious note that the LOA of the unit had expired on 17.04.2022 & unit was non-functional since 2018-19. The unit has not applied for renewal of LoA even after several reminders from the JSEZ office. After due deliberations, the committee unanimously decided **to treat the LOA of M/s Firestar International Pvt. Limited as cancelled as already lapsed with effect from expiry of its validity, i.e., 17.04.2022. This was keeping in view that no exports were undertaken since 2018-19.** Further, the Approval Committee also directed RIICO (Developer) to start appropriate action against the unit, as deemed fit.

14.2 Shri Naveen Prajapati & Shri Apoorv Mishra (both Partners) appeared before the Approval Committee and explained the proposal. On being asked by the committee, they informed that Unit will submit revised Form-F with correct details for further course of action.

14.3. After due deliberations, the approval committee approved in principle the proposal of M/s SJF JEWELS, for setting up of a Unit. This approval is subject to physical verification of its DTA unit & rectification of deficiencies already conveyed to unit.

The meeting ended with a vote of thanks to the chair.
